## Eligibility:

Entry is open to all artists. Work must be created outside of a class or workshop environment and completed within the last 3 years.

## Media:

All works on paper or canvas must be properly framed and wired for hanging (no clip-on frames or saw tooth hooks). Larger sculptures or other 3D works must come provided with suitable display stands. . Due to space limitations, The SAA reserves the right to refuse oversize works which may be problematic to hang or display or works whose subject is deemed non-PG. JPEG Image(s) submitted through this site must be artwork only, **no frames/no glass.**

## Online Entry Instructions:

All entries must be submitted as a .jpg file via [EntryThingy - Scituate Arts Association 2023](#). (link at top) There is a maximum of 4 entries per person. The .jpg files must be no larger than 8 Mb and the minimum image width is 900 pixels. Each entry will require a title and a "description" which is optional and defined with entry instructions. Also needed are the price and the dimensions of the piece to plan gallery space.

## Notification of Juried Status:

Entrants will be notified by email of their entries' status on March 21<sup>nd</sup>-23<sup>rd</sup>.

## Drop Off of Accepted Works:

Accepted works **must be hand delivered** to the SAA's **Front Street Art Gallery, 124 Front St, Scituate. Sat & Sun, April 1<sup>st</sup> & 2<sup>nd</sup>.** Drop off times will be announced in accepted emails March 21<sup>nd</sup>-23<sup>rd</sup>.

**Entry Fee: Non-members fee: \$15 per entry/3 for \$40.**  
**Members fee: \$12 per entry/3 for \$30.**

You may join or renew membership at the time of registration. The SAA will not accept entries for those whose membership requires renewing and will notify you of same. To double check on membership status email [scituateartsassociation@gmail.com](mailto:scituateartsassociation@gmail.com)

## Jurors: Jennifer Clark, Keith Conforti and Page Railsback:

**Awards:** \$500 prize for Best In Show, \$100 first prize awards (a total of up to \$1000 in prizes to be awarded). Ribbons awarded for first, second and third place in each category: oil/acrylic, watercolor, pastel, photography, drawing/printmaking/mixed media, and 3-D works. Sufficient numbers are required per category for award.

**Awards Reception: Friday, April 21<sup>st</sup> 7pm** at the Front Street Art Gallery, 124 Front Street, Scituate. Works will remain on display during Gallery hours 4/7 through 4/30.

## Accepted works pickup:

Front Street Art Gallery, 124 Front St, Scituate on **Sun, April 30 at 3-5 pm or Monday, May1, Noon-5 pm.** Gallery hours: Wednesday to Sunday, Noon-5. A storage fee of \$5 per entry will be charged after May 9.

**Liability:** Though care will be taken in the handling of works, the SAA/Front Street Gallery is not responsible for loss or damage.
